Declaration / Oath letter

I am fully aware that Electropathy /Electro Homoeopathy medical system is working at the stage of promotion, development & research under NEHM of India, New Delhi a competent authority of its kind. Ministry of Health & F.W., Govt. of India has issued a policy decision on 05-05-2010 in favour of NEHM of India permitting it for Electropathy education and practice. Hon'ble Supreme Court of India has already accepted /corroborated this policy decision on 22-01-2015 that there is no ban on medical practice of Electro Homoeopathy. With sincere efforts of it, Rajasthan Govt. gave recognition Electropathy by passing a Bill in Legislative Assembly on 9th March, 2018. Hon'ble Governor has already approved the Act on 10-04-2018. Recognition process of it by Central Govt. is under process. I also aware about the judgment of Hon'ble High Court dt. 26-05-2017 that the boards/organizations / societies/ councils registered only with S.R.Act, 1860 have no right to conduct examination and even award the degree /diploma/certificate. Hon'ble Supreme Court of India has already maintained this statusquo by dismissing SLP. On the basis of these orders, the agencies /companies /boards who are making Electropathic medicines prima facie have no right to manufacture medicine as their degrees/diploma/certificates also became illegal. Therefore, according the judgment of Hon'ble High Court duly affirmed by Hon'ble Supreme Court NEHM of India has full right to provide education, conduct examination and award diploma/certificate in Electropathy. Except this, all Boards/ Organizations / Societies are functioning illegally /incompetently.
